6. Operating instructions: by signing, the customer confirms that he has taken note of the following points:
- a. wood surfaces must not be permanently wet and must be allowed to dry. Temporary moisture, on the other hand, is harmless.
 - b. it follows that the underfloor ventilation must always be ensured. Thus, the gap must not be buried or otherwise obstructed.
 - c. in order for the pavilion to be storm-proof, it must be completely closed, Velcro must be pressed on, rubber ropes must be hung and doors must be locked (with tension belt, lock or built-in lock).
 - d. the construction is calculated for 20kg/m² snow. Further snow loads must be heated or cleared. With a snow load reinforcement this increases to 200kg/m².
 - e. The customer is responsible for all permits, both temporary and permanent.
 - f. for water pipes: frost-free up to the ground surface, electricity for trace heating and air heating in case of frost must be ensured
 - g. since the service life of the zippers depends significantly on careful use, they are excluded from the warranty. Before using the zipper, the wooden panels must be unscrewed and the tensioning loosened with rubber rope, The tarpaulins must be pulled into position by hand so that the zipper can be operated without tension. The tab of the zipper slide must point in the direction of pulling so that no transverse load acts on the slider. The correct use can also be looked up in the explanatory videos in our Youtube Channel.
 - h. If there is no objection within 48 hours, these conditions are valid as understood and accepted.
